To work with Mission Planners, Full Communion, ecumenical partners, pastors, lay leaders, all people of faith and good will to envision and plan for new missions in our Synod, and to work with existing congregations and ministries to make disciples in the places where we live and serve. By the grace of God and through your mission support we celebrate the following:

#### **A New Ministry Is Taking Root:**

**+The Swahili Lutheran Church** was approved as a Synodically Authorized Worshipping Community on May 20, 2017. They worship at Living Faith Lutheran Church in Rockville, MD. The Rev. John Mbatta, leader. \$15,000 from New Connections Campaign.



#### REPORT OF THE ECUMENICAL AND INTERRELIGIOUS TABLE

YEAR 2016-2017 CHAIR: REV. THOMAS PRINZ

The purpose of this Synod Table is to assist the Synod Bishop in the Bishop's function as chief ecumenical officer of the Synod.

The task of the unit is to monitor ecumenical relationships in this country and internationally; to manage local and regional relationships and activities; to help plan programs that explain ELCA growing ecumenical relationships and encourage congregations to engage their ecumenical and interreligious partners in witness to common concerns of justice and peace, witness and study, cooperation and prayer where these activities are possible.

This means the Table participants must study significant and related ecumenical and interreligious texts and resources with our local partners whenever possible and plan feasible events for joint learning and co-operation within the limits of our funding.

The year 2017 is dominated by the international and national observances of the 500th anniversary of the Reformation. Most attention has been given to the documents: From Conflict to Communion; its Study Guide and Common Prayer, a mutually agreed upon liturgy for use in congregations and assemblies of the church. This service order was used in the historic joint Lutheran and Roman Catholic worship service in Lund, Sweden lead by Pope Francis and Bishop Younan of the Lutheran World Federation. Other important resources include the document Declaration on the Way, a product of the United States conference of Catholic Bishops (USCCB) and the ELCA. Augsburg Fortress has also published an invaluable Resource book for use by parish planners.

What began as a trickle of material has now matured into a flood of books, essays and articles drawing attention to our roots in the past history of the church, our present realities and challenges, and the future promise of a Lutheran movement that has become an ethnically diverse, worldwide pluriform presence among an even larger Christian family of traditions.

An international conference in Washington D.C., has just drawn major thinkers from around the world on the topic: **Luther and the Shaping of the Catholic Tradition**. In October the members of the Synod will have an opportunity to attend several events co-sponsored by the Metro Synod and the German Embassy including the premier of a liturgical work title, "Mass of the Holy Spirit". Several of our congregations are making use of the rich resources in scholarship

and talent in our region to offer their own observances of the Quincentenary of the Reformation.

Other activities continue apace. In 2017 the Joint VA Clergy Planning Team of Episcopalians and Lutherans is sponsoring days of reflection and prayer in four locations around the Commonwealth. On Dec 1 and 2 the VA Lutheran-Anglican-Roman Catholic-United Methodist planning group (LARCUM) is planning its annual meeting in the Richmond area with Dr. Susan Wood, principal Roman Catholic drafter, along with ELCA Kathryn Johnson, of **Declaration on the Way**. Last fall Dr. Joseph Small of the Presbyterian Church, USA made a significant contribution to understanding the contribution and challenge of the Reformation event to our current witness.

Other events include several observances of the Week of Prayer for Christian Unity (WPCU). At the Northern Virginia event in which our regional bishops' often take a part we welcomed Bishop Michael Burbidge to the Diocese of Arlington and Bishop Sharma Lewis to the United Methodist Conference headquartered in Richmond.

Our jurisdictional leadership continues to change as we have now expressed our gratitude to Bishops Cho (UMC), Loverde (RC) and Mauney (ELCA), who have retired. Their contributions have been vital to their own churches and to the larger ecumenical and interreligious community.

We continue to maintain relationships with the VA Council of Churches; Interfaith Conference of Washington, Washington Theological Consortium (which has welcomed two new institutional members as it prepares to work with our new United Lutheran Seminary in Gettysburg). Regular gatherings of the regional Lutheran Episcopal Coordinating Committee (LECC) and the Lutheran-Roman Catholic Conversation (L/RC) whose beginnings go back to the end of Vat. II! This results in a catalogue of over 40 face to face meetings and 24 conference calls over the last year. Members of the Table provide not only a presence but leadership in all these venues. Members of the Table have attended the National Workshop on Christian Unity (NWCU); the North American Academy of Ecumenists (NAAE); annual conference of Center for Catholic and Evangelical Theology, as well as a Lutheran-Roman Catholic Conference in W. VA.

In these ways the Table seeks to serve the ecumenical and interreligious participation of the Synod in accordance with our Synod Constitution which commits us to the task of unity in our place and in our time.

#### **GLOBAL MISSION TEAM**

The Global Mission Team focused upon the enabling of congregations to proclaim Jesus Christ throughout the world by way of Companion Synod relationships with Lutheran Churches in Namibia, El Salvador and Slovakia, advocacy for peace throughout the Middle East Working Group, support of the ELCA Malaria Campaign, the work of the Immigration Team, ELCA Global Church Sponsorships, and Gifts of Hope.

#### **COMPANION SYNOD TASK FORCES:**

#### A: Namibia – Kathryn Tobias & Mark Victorson, Chairpersons

Visit of Bishop Ernst //Gamxamub and Finance Minister Leonard de Vries to Metropolitan Washington, DC, Synod, May 1-5, 2016.

Following visits to Chicago and to companion synods in Southwestern Washington and Northeastern Iowa, Bishop Ernst and Mr. de Vries visited the DC Metro Synod before traveling to the final synod, New Jersey, on May 5. After arriving on Sunday evening, May 1, at the home of Lutheran Church of the Reformation Pastor Michael Wilker, they shared a small dinner with his family, Kathryn Tobias, and Pastor Al and Nancy Swingle. On Monday morning they visited Lutheran Social Services, hosted by Kati Miller Holland, Dara Yahya and other staff and learned about the Youth Haven Camp, which addresses the needs of children and youth in families affected by HIV/AIDS and the alienation that often surrounds them. They were then hosted at the Folger Shakespeare Library by Dan DeSimone and staff, who showed them books by Luther from as early as 1518. After a German lunch, they visited Patricia Kisare at the ELCA Washington Office and discussed issues before Congress and in the U.S. government related to international relationships. In the evening, Bishop Ernst preached an Ascension Day sermon, reminding us that as Jesus goes to prepare a place for us, we are each known by name.

On Tuesday morning, Ambassador Martin Andjaba and staff welcomed the visitors to the Namibian Embassy in Northwest Washington, DC. The Ambassador affirmed his support for and interest in the Namibian-North American companionship of Lutherans and said he would welcome being a part of future celebrations. In the afternoon, Bishop Ernst and Mr. de Vries traveled to the home of Pastor Bob Allard in Woodbridge for a two-day stay. Over dinner, they met with the Namibia Companion Synod team (Mark Victorson, Kathryn Tobias, and Pastor Elijah Mwitanti) and representatives of the independent nonprofit, Friends of Namibian Children (FNC). The group hashed out some concerns and FNC agreed to work together with the Bishop's office on a Memorandum of Understanding to improve transparency in the relationship.

On Wednesday, the visitors participated in the Fairfax Conference meeting at St. Mark's Lutheran Church where Bishop Ernst and Bishop Richard Graham met for the first time. In the afternoon, hosted by tour guides Bob Allard and Mark Victorson, they visited several outstanding nonprofits: Good Shepherd

Housing, the Hilda Barg Homeless Prevention Center and Action in Community Through Service (ACTS). Bishop Ernst led an evening gathering of confirmands and participated in a hymn sing at St. Matthew's Lutheran Church in Woodbridge. On Thursday morning, the Woodbridge Rotary Club, which has been supportive of the hostels in Namibia, welcomed the visitors for lunch. And at 3 pm, they were returned to Washington for a wrapup meeting with Bishop Graham at the Metro DC Synod office. They shared a simple supper at a "Glocal" meeting at Church of the Reformation and boarded the train for New Jersey, and ultimately the flight home.

Companion Synod Sunday, 31 January 2016. Metro DC Synod Namibia Team put together a packet of materials about Namibia for Companion Synod Sunday, which included a Companion Synod Sunday flyer, a Friends of Namibian Children flyer, and Sunday Church School lesson plans for pre-school and kindergarten through middle school classes, a Namibia fact sheet, photos, and a flyer for the Friends of Namibian Children's Summer Sundae fundraiser, which was held on the same day. Churches throughout the Metro DC Synod used elements of the packet during their celebration of Companion Synod Sunday.

Mission Trip to Namibia. On 19 July 2016, a mission team of 15 parishioners from St. Paul's Lutheran Church, Washington, DC embarked on a two-week mission trip to Namibia. The mission trip involved visiting and working at two hostels, one in Karibib, where the team spent most of its time, and the other in Otjimbingwe. The team also worked at a Children's Education Center in Usakos. The team worked hard with the guidance of Hope for Kids to repair, build, paint, and do plumbing. The team also built a gated hallway, so the children could have access to the bathrooms at night. Playgrounds were rebuilt and painted, and the team involved the hostel children in the work. The children helped paint a beautiful mural of the world on the side of one of the buildings. The night before it departed Namibia the team had dinner with Bishop //Gamxamub. The team members considered this a trip of a lifetime and a true blessing to them, as well as to the children of the hostels.

#### Friends of Namibian Children

Namibian Summer Sundae Fete, 31 January 2016. The eastern FNC Board of Directors Team held its first fundraiser, a Namibian Sundae Fete and silent auction at Resurrection Lutheran Church in Arlington on Sunday, 31 January 2016. It seemed appropriate to have an ice cream social in February, because it was summer in Namibia. The Fete was very successful and included addresses by Bishop Graham and Ambassador Andjaba and remarks by FNC Chair, Rachel Schmidt; CEO of Hope 4 Kids International, Ken Eggum; and Bob Allard, who thanked donors, to include major donors, the Woodbridge Rotary Club, which donated \$1400; and Thrivent Bull Run Chapter, which donated \$1000. There was a good turnout, informed a number of interested people about Namibia, and raised over \$5000 for the various projects FNC is carrying out in support of the school hostels run by the ELCRN in southern Namibia.

**FNC and LCRN MOU.** At Bishop //Gamxamub's request, made during his visit last year, FNC has written a draft Memorandum of Understanding (MOU) detailing how the relationship between FNC and the ELRCN Synod will work in support of the hostels. The draft MOU has been submitted to ELRCN and FNC is waiting for a reply. The ELCRN's Director of Hostels has developed health issues, and there is some question concerning the future leadership of the hostel program.

#### B. El Salvador – Kelly Baugh & Phil Loar, Chairpersons

Phil Anderson shared that gang violence is on the rise in El Salvador from drug trafficking to extortion. Travel is dangerous. Prayers are asked for the country in dealing not only with gang violence, but also refugees. Bishop Gomez visited DC the end of February. Lutheran Churches are trying to help with the gang problems as part of a Nationally Covened Presidential Committee to deal with these problems.

Synod Immigration Team and AMMPARO. Kelly Baugh reported that the Synod Immigration Team is looking at reaching out to congregations about AMMPARO (Accompanying Migrant Minors with Protection, Advocacy, Representation, and Opportunities). According to ELCA, "amparo" in Spanish means the protection of a living creature from suffering or damage. ELCA's AMPARRO strategy "was envisioned after witnessing the plight of children who are forced to flee their communities in El Salvador, Honduras and Guatemala." The welcoming congregations initiative is broader than just El Salvador. Phil Lohr says the synod will expand welcoming beyond the level of the 'reconciling in Christ" initiative of years past. Meetings will be held in the synod to make a plan. As reported previously, through AMMPARO, congregations agree to welcome migrant children and families, listen to their stories and receive the divine blessings that they bring, pray for and share the gospel, provide emotional and spiritual support, accompany migrants to access institutional services as needed, and advocate for justice for and with migrant families and children. "Guardian Angels" are present in courtrooms and legal hearings, where migrants, including many mothers, are not always afforded their legal rights.

Two groups are planning trips to El Salvador—Marion and Phil and a group from Holy Trinity; and Kelly and Bishop Graham and Pastor Lynn. Kelly noted that their group is going to learn more about the ministry there and to support people here as well.

Stephen Deal, ELCA Regional Director for Central America, was in Washington on a home visit for two weeks. He visited with three conferences of the synod—Virginia, Fairfax, and DC (Christ Lutheran), with a lot of his work having to do with ELCA's AMMPARO initiative. He has preached and led adult forums related to these issues. The number of unaccompanied minors has gone up to the same level as in 2014 and the number of families went higher. Now the

population of undocumented has gotten larger since 2014 and the challenge has gotten bigger. Bishop Gomez has spoken on why people are emigrating from El Salvador. Steve discussed various situations and abuses and mentioned an article for *The Lutheran* Magazine in 2014 which talked about families having to get children out because of bad situations in their home countries—he drew a comparison with Moses being left in a basket. Situations might be overwhelming, as in Guatemala, where a gang comes in demanding bus drivers pay--so extortion may result in no transportation available for rural families even to get to larger towns to buy groceries. When families have to get their children out, the "coyote" may take the titles of their houses as a bond. If kids get a job and pay the price, the family may get the title back—or they may lose their home. Churches have done followup of kids and families in situations and found youth severely traumatized—if the cycle is not broken through reconnection with education, vocational training, microenterprise, it will occur again.

Funding is an issue—e.g., El Salvador may receive \$55,000 annually from ELCA, but that is a drop in the bucket to address the issues. If something doesn't happen at the congregational level, it goes nowhere—question is what are we doing?

"Catch and Release"—when a minor comes across the border and turns self in—which is the legal thing to do—Customs and Border Patrol has to handle it differently—move the child to a child-appropriate facility and in the next 10 days work to identify someone in the United States who will assure legal responsibility. It is better if they have a parent or someone authorized by the parent to make sure the kids show up at hearings—UP TO NOW. Border Patrol, "tired of being day care centers," just put them all in detention facilities. For smaller children, since there were not adequate facilities, reactivated private for-profit detention facilities. Leads to trauma—seems to be where it's going.

The response to the wave of immigration, churches have said, needs to be on the basis of Biblical principles—welcoming the stranger. Mary Campbell, the full-time director for AMMPARO, encourages good lawyers in ELCA congregations to step forward and help as "Guardian Angels." It was suggested that congregations be contacted to put together a network of lawyers in the synod. Having a lawyer in these cases increases the chance of a case being decided in the client's favor from 15 percent to 70 percent.

Now with the election, the ground is shifting underneath. It wasn't planned this way—what is happening at a church level is on a collision course with what's coming out of the new administration. The US election represents a shift in the context of dealing with this migration. The churches knew that an executive order was coming and now need to build alliances to respond. Some churches are considering the option of becoming sanctuary churches; others are not comfortable with that but are looking for neutral places where discussions can take place. A congregation in North Carolina with a Mexican pastor and significant Latino membership worries about how the E.O.s will affect them. One area of focus is the lawyers' network. The advocacy area is also critically important. AMMPARO was initially passed as a strategy at the synod level, but in

practice it is a movement across ELCA. Other denominations are now looking at it. Mary Campbell has received expressions of interest from 25-30 synods.

#### C. Slovakia – Rosemary Burton, Chairperson

An e-mail was received concerning how the refugee crisis in Europe is affecting Slovakia. Churches there took a special offering to help refugees seeking asylum.

A video was shared on the Christian Education Center in Martine. They have a new building and progress is good in reaching students from preschool on up.

Also shared were pictures of a number of churches in Slovakia. Churches there are hundreds of years old and in dire need of modernization, i.e., roofing, electricity, heating, sanitation, etc.

#### MIDDLE EAST WORKING GROUP - Nathan Rich, Chairperson

Bright Stars of Bethlehem produced its annual "Room for Hope Festival", a Palestinian Arts Celebration, in the DC area in September. Dr. Mitri Raheb at Faith Lutheran Church Arlington, VA. Other events took place at The Jerusalem Fund, Georgetown University, and Busboys & Poets - Brookland. See <a href="http://roomforhope2016.eventbrite.com">http://roomforhope2016.eventbrite.com</a> or brightstarsbethlehem.org. MEWG contributed \$250 from its budget to support these events.

Bishop Graham participated in the 10th Annual Bethlehem Prayer Service, a simulcast between Washington National Cathedral and Christmas Lutheran Church in Bethlehem, Palestine, on Saturday, December 17, at 10:00 AM in DC and 5:00 PM in Bethlehem. Prayers, readings, and hymns alternated between Washington, DC and Bethlehem via live simulcast, bringing together people of different lands, languages, and ethnic backgrounds in celebration of Jesus' birth. Those unable to join in person were invited and encouraged to join on-line at <a href="https://www.cathedral.org">www.cathedral.org</a>. This service is also coordinated by Bright Stars of Bethlehem.

In 2016 the ELCA Churchwide Assembly passed two important memorials on Israel/Palestine: The first calls on Congress to make aid to Israel contingent on cessation of support for settlements in the Occupied Palestine Territories (West Bank and East Jerusalem). The second calls for development of a human rights social criteria investment screen. The ELCA Peace Not Walls team and ELCA Synod Middle East Network works to implement these resolutions (<a href="https://www.elca.org/peacenotwalls">www.elca.org/peacenotwalls</a>).

The MEWG mourns the passing of one of its most dedicated members: On August 15 Pastor Phil Anderson died of cancer at age 69. A memorial service was held Thursday October 13 at First Trinity Lutheran Church in DC.

#### **ELCA WORLD HUNGER** – Dorothy Sorrell, Chairperson

The year 2016 marked the beginning of an effort to make ELCA World Hunger information more widely distributed, and the ministry of this program better understood. Looking forward to 2017, it is hoped that more congregations will participate in World Hunger giving as individuals step forward to serve in this effort.

A World Hunger display was prominent during the Metro DC Synod Women's Organization meeting in April 2016, and resources shared with individuals at that time. Because displays were not possible at the Metro DC Synod Assembly in June, ELCA World Hunger note cards were provided to all Assembly members along with contact information for the Synod World Hunger Hunger Coordinator. Some synod members attended the ELCA Region 8 Meeting in October, where World Hunger staff provided information about future initiatives. It should be noted that ELCA World Hunger Education Unit participated in and helped with the financial support of "The Forgotten Luther" Symposium that was held in the Metro DC Synod, and led to the publication of the booklet, "The Forgotten Luther: Reclaiming the Social-Economic Dimension of the Reformation".

Michael Kuchinsky reported on the project that he and Dick Hoehn are working on to tie congregations in to the United Nations sustainable Development Goals, which were voted in September. #### THE METRO DC SWO MINISTRY APRIL 2016 THROUGH MAY 2017

**2017 SWO Convention:** The Annual Spring Convention of the Synodical Women of the ELCA celebrated the theme of "All Anew," which was based on Isaiah 43:19, "I am about to do a new thing ..." It was held at Peace Lutheran Church, Alexandria, VA, on Saturday, May 6, 2017 and by all reports it was a success! The women of Peace were wonderful hosts and treated us to a Continental breakfast and a delicious sandwich lunch along with their warm hospitality.

At our business meeting, the voting members approved our standard reports and passed our current year's budget and a draft budget for 2018-2019. They also elected a new Vice President and reelected our Treasurer and one Board Member for two-year terms as well as one Nominating Committee member (Ann Nuss, Saint Luke, Silver Spring) for a one-year term. We are still seeking to add two additional Nominating Committee members for next year's convention. You will find a list of current Executive Board members included at the end of this report.

The Reverend Sarah Scherschligt from Peace Lutheran led our communion worship based on the Holden Evening Prayer Service and Bishop Richard H. Graham gave the homily. After the service, Patti Austin, president of churchwide Women of the ELCA, installed our SWO officers and board members for the upcoming 2017-2018 year.

Our Plenary Session, "All Anew—The Women of the ELCA," was led by Patty Austin, who was also our special guest and representative from churchwide WELCA. Using PowerPoint slides with many photos she took over her three-year tenure as churchwide Women of the ELCA president, she gave us an interesting first-hand look through her travels to Tanzania and Guatemala at what is happening internationally with the Women of the ELCA as well as what is going on within the US. She held an interesting Q&A session at the end of her talk.

Our workshops were well received and included "Gifts for You" by Patty Austin; a session on "Women in Agriculture around the World" presented by Kristin Vought, Philanthropic Associate, Lutheran World Relief; a study of Post-Modern Christianity entitled "A Vision of the Future Church" led by the Rev. Mike Gutzler (Holy Trinity and Mosaic District); and an interactive "Introduction to Tai Chi" session led by Alan "Rob" Robertson, Catalyst Personal Fitness.

Our community booths and vendors included Beading for Haiti (Chris Jensen, Peace Women of the ELCA), ELCA World Hunger (Dorothy Sorrell), Fair Trade Winds (Paul Culler), Gifts of Hope (Carolyn Sowinski), Lifeline Partnership (Suzanne Blume), Lutheran Social Services/National Capitol Area (Lisa Johnson), Lutheran World Relief (Kristin Vought), Thrivent (Sheri Swackhamer), La Sagrada Familia (The Rev. Rosario Hernandez), SWO Human Trafficking Awareness (Wilma Dublin), and SWO/Women of the ELCA/Tenth Triennial Gathering (Karen Evans, Bonnie Priebe).

From the 60 convention attendees, we collected 348 "Personal Care Kits" for Lutheran World Relief as in-kind gift donations (which were transported the following Tuesday to the LWR warehouse in New Windsor, MD). Our convention offering was divided equally between churchwide Women of the ELCA and a local charity, Annandale Christian Community for Action (ACCA).

At the end of May, we are wrapping up our two-year project to raise money for *La Sagrada Familia*, affiliated with Saint Luke Lutheran Church in Silver Spring, MD.

**Human Trafficking Awareness Initiative:** Acting on a memorial from the 2014 Triennial Convention and as a follow-on to our 2015 SWO Annual Spring Convention focus, our SWO Human Trafficking Awareness committee continued its work to raise awareness of the human trafficking in our area and to also report what is being done to combat it.

SWO Vice President and our committee chair Wilma Dublin has been a strong leader and catalyst for this committee, and as she has now completed her tenure, we are seeking a new committee chair. Here are some of her accomplishments with the committee:

- Last summer, she served as a mentor to a group of victims at a trial in Alexandria after which the trafficker was found guilty and is now awaiting sentencing.
- She advised us that the June issues of *Gather* and *Living Lutheran* featured articles addressing this issue.
- She conducted seminars to encourage awareness of this problem to several of our churches within the synod and to some other groups who requested information, showing the short DVD "Chosen" to some of them.
- Her articles in our newsletter, *The Joyful News* and on our website along with the committee's poster campaign against Human Trafficking in early 2017 helped to spread the word that Human Trafficking is a form of modern-day slavery—it involves the use of force, fraud, or coercion to exploit human beings for some type of labor or commercial sex purpose.
- The committee and their poster campaign highlighted the multi-lingual National Human Trafficking Hotline (NHTH) number 1-888-373-8888.
- Their poster campaign involved mailing and hand-delivering packets of posters, flyers, and other handouts to every church in our synod and encouraging them to place the posters in their church buildings and to seek permission to post them in their communities in grocery stores, libraries, and other places with pedestrian traffic.

Spearheaded by the diligence of committee chair Wilma Dublin and board member Karen Evans, their committee efforts on Human Trafficking Awareness even made the churchwide Women of the ELCA news! Terry Lackey, Director for Communication of churchwide Women of the ELCA, wrote the story of their poster campaign for churchwide Women of the ELCA "News & Events" section and also published it in the April 1, 2017 issue of the monthly "Bold Connections" e-newsletter. **Communication**: The website and Facebook page continue to be active with links to and the promotion of SWO events, messages of interest to the units, WELCA information, and blogs. In addition, we now post the minutes of our SWO Executive Board meetings on our website.

Our newsletter, *The Joyful News* was published in August, December, and March, informing units about current events within the SWO, resources available, happenings around the Synod, and promoting our fundraiser for the last two years, *La Sagrada Familia*. A special edition was also sent in June that reported on the April SWO convention and highlighted the upcoming *Grace Gathering* in August in New Orleans and the 10<sup>th</sup> Triennial Gathering coming up in July 2017 in Minneapolis. The email distribution project for *The Joyful News* continues to be successful, saving the organization a considerable amount in postage and paper. A paper copy is sent to those units and some individuals not wishing to receive the digital version. *If your church office or WELCA/SWO contact is not receiving <u>The Joyful News</u>, <i>please advise us*.

Our SWO 2015-2017 Giving Project: The La Sagrada Familia campaign has been our focus for the past two years and was active through the end of May 2017. La Sagrada Familia is a mission project of the ELCA (Metro DC Synod) and works closely with Saint Luke Lutheran Church. It has over ten years of experience in accompanying the Latino and other immigrant populations in defending housing rights of apartment dwellers, creating jobs, and especially improving educational opportunities for children. Pastor Rosario Cruz and her volunteers from Saint Luke and a group of students from the Lutheran Campus Ministry at the University of Maryland provide food, clothing, school supplies, and help with homework, crafts, and games during an after school program. Psychological help is also available as is an ESOL program geared to adults. We will be gifting them our collection in June after the campaign has ended.

**2017 Tenth Triennial Convention and Gathering:** Registration continues for the 2017 Tenth Triennial Gathering, themed "All Anew," to be held July 13-16, 2017, in Minneapolis, Minnesota. This year they are encouraging registration for young women ages 6-18, with special programming for our younger guests. At last count, we have 23 women planning to attend from our Metro DC Synod.

The Tenth Triennial Convention precedes the gathering and is to be held July 11-13, 2017, in Minneapolis. Our three voting representatives this year are included at the end of this report.

**Growing the SWO**: This is an ongoing mission to expand our active units in the Synodical Women's Organization. We are able together to do more than we could do as an individual church. We have been talking to you, trying to understand your needs and desires. We know we are a diverse group across a large age span. But that does not mean we should continue doing everything we have always done, the same way we have always done it. There is something for everyone—a prayer group, a Bible study group, a circle, a monthly meeting, service projects, a Prayer Shawl group, a *Café* group for mothers and/or younger members—or perhaps you have an idea you would like to try. All of these things are possible through Women of the ELCA. Let us come to your congregation, explore with you the opportunities with the WELCA of today.



As the ELCA commemorates the 500<sup>th</sup> anniversary of the Reformation, we are reminded that *the church should always be reforming* — adapting to a changing landscape even as it stands firm in its mission. In 2016, Portico's ministry epitomized this combination of innovation rooted in mission, as we expanded our service and stewardship in new ways while continuing to provide cost-effective, high-quality health and retirement benefits for more than 46,000 active and retired ELCA rostered ministers, lay employees, and their families in partnership with the almost 6,600 ELCA churches and employers we serve.

We championed a wellness reformation in the ELCA, inviting a recommitment to healthier lifestyles and a healthier church. For the first time, we formally extended our annual wellness challenge to congregations. Also a first: We surveyed those already living a healthy lifestyle, and more than 1,800 members and spouses shared inspiring testimonies of the life-changing power of prioritizing one's physical and emotional health.

We offered a new approach to providing health care. In response to the growing prevalence of chronic disease and rising claim costs, we introduced Portico Care Coordinators by Quantum Health to help members navigate today's complex health care system and get the best possible care at the right price. The anticipated savings from this industry-leading approach was one of several cost-containment measures that helped us hold 2017 health contribution rates to the lowest increase in four years.

We answered the church's call for socially-informed investing. We strive to live out the church's mission and make an impact in God's kingdom as we manage the assets in the ELCA Retirement Plan. Memorials at Churchwide Assembly in August affirmed the three powerful ways we impact corporate behavior through shareholder advocacy, screening, and positive investing. The Assembly also called for even broader work on the environment and human rights; in the coming months, we look forward to partnering with the ELCA to develop screens that will guide future investment opportunities.

We developed new support for financial decision-making. For two decades, Portico has been a leading voice in the ELCA connecting the importance of physical, emotional, and financial health to ministry. In response to members' desire for an easier way to manage their retirement savings, we developed new benefits that will help our members better assess their readiness for retirement, and will provide personal assistance to help them reach their financial goals.

These efforts — and many more — come thanks to a dedicated, creative staff constantly seeking to improve our internal operating processes, maximize efficiency, and be good stewards of the resources entrusted to our care. Their efforts helped ensure that for the third straight year, Portico's capital and operating expenses were under budget, and we maintained ELCA Health Plan and Retirement Plan expense ratios lower than our benchmarks. As the church adapts to today's changing landscape, Portico is well positioned to continue to provide the best possible care for our members, so they can serve the world with confidence, resilience, and faithfulness.

Lutheran Campus Ministry at the University of Maryland is known on campus as The Humble Walk, a place where students from all backgrounds and denominations come to engage in the gospel through worship, community engagement, after school programs for at-risk youth, small groups, and service and cultural immersions.

#### Yearly Update:

- This semester we have seven students leading discipleship small groups of 4-5 using the 3DM Huddle model. These groups focus on scripture study and taking a closer look at how God is moving in their lives.
- In the past year we have gone on two service learning trips. In June we took 15 students to Haiti to walk with the local church, and local LWR and LWF organizations. In March we took 16 students on joint alternative spring break to Lumberton and Pembroke NC with the Baltimore Area Campus Ministries to aid in flood rebuilding and engage with the local Lumbee Tribe.
- In January we went to Philadelphia for a leadership development and vocational discernment retreat. We spent time with the faculty at LTSP, learned from community members who are living out their faith in their work and explored the city.
- Our after school tutoring and mentoring programs, CARing and En Camino continue to connect our ministry with university and elementary students in an joint effort to help those children succeed. Joyful Noise, our praise band, visits congregations throughout the area to share our students' musical gifts.
- Our Sunday night dinner and worship has grown to an average of 30 students up from 25 last semester!
   We regularly have local congregations that provide a meal and sometimes bring their youth to show them what campus ministry looks like. After dinner we worship together on couches and comfy chairs, sing, pray, hear student testimonies, and celebrate the Eucharist. We are very intentional about being welcoming to new people and explain each part of the service as we do it.
- In addition to the things mentioned above we also play intramural sports, host game nights, head to the movies together, pick up basketball and soccer, play paint ball, and more!

#### **Gettysburg Seminary Report 2017**

#### Imagine a Stronger Seminary & Unprecedented Seminarian Support

Imagine one Lutheran seminary in Pennsylvania that is stronger than its combined separate predecessors in Gettysburg and Philadelphia. Imagine an unprecedented level of student support. Imagine a seminary educating across two campuses, in hybrid and online formats as well, with a faculty filled with unparalleled expert pedagogues. Imagine a state of the art school that provides a leading edge curriculum with the deepest, classical roots on the continent. Imagine United Lutheran Seminary, opening July 1st 2017!

#### **Full Scholarships Signal Students First**

For more than a decade there has been growing concern about the financial burdens incurred by seminarians in this era when "church support" has continued to decline as a percentage of budget. But in a bold and dramatic move, both PA seminaries announced full tuition scholarships for all full-time ELCA students. The budget for United Lutheran Seminary gives priority to what we've called a "Students First" approach to planning. This can be sustained only with continuing strong support from synods, congregations and individual donors. To all who are making possible this bold and unique offer, we say a hearty word of thanks!

#### **New Curriculum Integrates Classroom and Context**

Perhaps the newest feature of ULS is an emerging curriculum fully designed for the 21<sup>st</sup> century. Rather than simply passing courses, students will be expected to demonstrate having mastered a high level of competence in all critical ministry leadership areas. Virtually every course will include professors from more than one discipline working collegially to bring to bear insights from their fields of expertise.

#### **Continuity Assured**

In the midst of newness is a reminder of the richness of the two seminaries' distinctive and complementary heritages. Even as we bid farewell to faculty and staff members who are retiring or moving to new callings, we celebrate that almost the entire initial United Lutheran faculty will be comprised of current members of the Philadelphia and Gettysburg teaching theologians. Certificate study and Lifelong Learning opportunities continue on both campuses. Both Town and Country Church Institute and the Urban Theological Institute carry forward, as well as beloved traditional annual events like Advent Vespers and Music Gettysburg! concerts. Also to be sustained are recent new initiatives that better equip students to integrate faith and science, ministry with those in prison, and ecological "greening" endeavors to enhance environmental care.

#### **Faculty Tapped**

In addition to their classroom teaching, speaking in multiple church settings and other arenas, faculty members fulfill responsibilities as scholars with increasing national and international recognition. This past year, several faculty members have been asked to teach courses in other institutions, including Lancaster and Pittsburgh Seminaries. In recognition of his expertise in rural ministry, ethnographic studies and multiple point ministries, Dr. Gil Waldkoenig has accepted a half-time position as ELCA Director of Evangelical Mission for the West Virginia/Western Maryland Synod. And beginning this summer, Dean Kristin Largen will serve half-time as Gettysburg College's Chaplain and Associate Dean of Religious and Spiritual Life.

#### **New Leadership**

A presidential search is underway in light of the consolidation of the two seminaries. As of print deadlines for assemblies, the search is on track for the election of a new president before synod assemblies begin. Watch for an update at the assembly. And receive our profound gratitude for the synod's unwavering support!

### 2017 Report of the Eastern Cluster of Lutheran Seminaries to the Synods of Regions 7, 8 and 9

In the rapidly changing landscape of theological education, "status quo" has less and less meaning. Instead, we might talk about a "fluxus quo," as change and flux seem to be the "new normal." The Eastern Cluster of Lutheran Seminaries is no exception.

For those less familiar with the Eastern Cluster, this was the separately incorporated entity created by Lutheran Theological Southern Seminary, the Lutheran Theological Seminary at Gettysburg, and the Lutheran Theological Seminary at Philadelphia to create efficiencies by inviting shared use of resources and greater interaction between the faculty and staff of our institutions. Since its founding in 1995, the Eastern Cluster has fostered strong collaboration between the three eastern schools and other partners, enhancing our common task of theological education for a broad spectrum of students and lifelong learners.

Across its history, the Cluster has successfully received grants from a number of foundations — Lilly Endowment, Luce Foundation, Teagle Foundation, Thrivent — as well as ELCA research and development grants made available by the Division for Ministry. Over the course of its life, in excess of \$6 million has been garnered for Clusterwide projects. Among other projects, the creation of One Library Under Three Roofs (linking the three campus libraries into a unified system), Project Connect (a vocational discernment and recruitment effort), and various attempts to build a robust coordinated Cluster program of continuing education received the largest grants, and probably had the greatest impact. Most recently, the Cluster has received a renewal and extension of the Lilly-Endowment funded Abundant Life grant to help reduce student debt, teach greater financial acumen among our students, and promote holistic stewardship in the personal lives and congregations of our graduates.

Other major emphases and programs include Cluster sponsorship of the annual Diaconal Ministry Formation Event (with faculty from the three schools contributing), significant Cluster budgetary support for the Atlanta program (an Afro-centric studies project in collaboration with the Interdenominational Theological Center), and a collaborative Doctor of Ministry program centered at Philadelphia. Most recently, the schools have worked with colleagues from the ELCA on carrying out a consultation on the Cluster archives, and an upcoming LWF trip to Namibia supported in part through funds designated for use in the Cluster (the Marple Fund).

In recent years, there have been a number of changes to the Cluster. In 2009, the Cluster was "downsized" to reduce administrative costs. In 2012, it adapted to the incorporation of Lutheran Southern Seminary into Lenoir-Rhyne University. And today it is responding to the unification of LTSG and LTSP into United Lutheran Seminary. Despite these changes, the goals of the Cluster – to foster shared resources and encourage collaboration in order to enhance and broaden theological education – remain the same, even as the form of that cooperation continues to evolve. Currently, the governing board is considering whether the administrative structure of the Cluster is a help or hindrance to continue our shared library system, support our faculty fellows, facilitate the opportunity to seek impactful grants, and increase the potential to create cooperative systems of education for the larger church. As we explore various possibilities for faithful and efficient sharing of resources, we are grateful for the encouragement, prayers, and support of our synods and larger church. Theological education for the whole church has never been more important, and the Eastern Cluster of Lutheran Seminaries has been privileged to support that endeavor.

### NATIONAL LUTHERAN COMMUNITIES & SERVICES 2016 SYNOD REPORT

Serving seniors since 1890, National Lutheran Communities & Services (NLCS) continues to write the chapters that will prepare the organization for another 126 years. While seniors' needs will continue to change, one thing remains constant—our unchanging values.

National Lutheran Communities & Services: In 2016, the National Lutheran family served more than 1700 seniors and employed 600 individuals. The Community Impact Grant program continued to grow, awarding \$221,250 to 21 social ministry organizations serving seniors. A partnership with American Public University allows employees to take advantage of National Lutheran's tuition reimbursement program. Staff also collected 454 pounds of food to donate to Manna Food. The Village at Rockville: Approximately \$269,999 in charitable care was provided to residents who could no longer afford the cost of services, and over \$7.3 million was provided in contractually discounted care. Plans are underway for an expansion project that will offer 130 independent living apartments. Residents lent 2080 hours to provide preemie blankets, scarves and hats for needy women and Afghans for children. Residents and staff raised \$2,849 for the Alzheimer's walk, with 64 participants. Monthly support groups offered comfort and resources, while 75 coats were donated to area homeless shelters. <a href="https://www.thevillageatrockville.org">www.thevillageatrockville.org</a>

The Village at Orchard Ridge: The community had numerous openings and celebrations in 2016, including its Engage Center that features an indoor pool along with therapy, art and multipurpose rooms. The 150-seat dining addition and patio kitchen also opened. The Phase 2 expansion was completely presold, with move-ins starting in December. Phase 2 will add 150 new residents to the campus. Monthly public concerts heralded the new Letourneau pipe organ, averaging 200 attendees. Residents donated 75 blankets to the local animal shelter, along with 240 sets of hats and scarves to needy children. Furthermore, \$127,194 in charitable care was provided to residents who could no longer afford the cost of services and \$323,294 in contractually discounted care. www.thevillageatorchardridge.org

The Legacy at North Augusta: Transforming from purely independent living to now offering primarily assisted living, The Legacy at North Augusta further adapted to meet the needs of its residents in 2016. Staff and residents raised \$2,677 for the annual Alzheimer's Walk, with 30 attendees. Approximately 110 pairs of new shoes were collected for the Well of Hope program in Kenya. myPotential at Home: myPotential at Home provided approximately 30,000 hours of personal care to seniors in Virginia last year. From assisting with bathing, preparing nutritious meals, transporting seniors to important medical appointments or even walking some four-legged friends, the team kept over 110 people safe and happy in their homes in Frederick, Shenandoah and Warren Counties. myPotential at Home further expanded in Virginia in 2016 to offer home health services, and also created a presence in Maryland with offering home care services. www.mypotentialathome.com
